MD/MS/PG Diploma and MDS Admission Notification-2016

Notification No. 119-BOPEE of 2015 Dated: 17-12-2015

Online applications are invited from the candidates interested in appearing in the Entrance Test for admission to **MD/MS/PG Diploma Courses-2016** in the Government Medical Colleges of Srinagar and Jammu, SKIMS-Srinagar & ASCOMS-Jammu and **MDS Courses-2016** in the Govt. Dental College, Srinagar. The candidates must be permanent residents of the State of Jammu and Kashmir and eligible to appear in the Entrance Test under relevant rules and Regulations. The selection of the candidates will be governed by the J&K Board of Professional Entrance Examination Rules, 2014, JK Reservation Act, 2004 JK Reservation Rules, 2005, MCI and DCI Regulations and Guidelines as contained in the Electronic Information Brochure-2016. The Rules and E-Brochure are available on the official website of the BOPEE www.jakbopee.org / www.jakbopee.net.

Online Application Forms

The Applications have to be **submitted online only** through BOPEE websites www.jakbopee.org / www.jakbopee.net from **21st December, 2015 to 15th January, 2016**. The payment of rupees 1600 (Rupees one thousand and six hundred only) as fee is to be made also online through the HDFC integrated Payment gateway which can be used to make payment with any national Credit Card/Debit Card issued by any national bank. Candidates can avail the facility of Khidmat Centre (CSC) for uploading the online Application Form at nominal payment. The procedure for filing Application Form and eligibility etc of the candidates have been given in detail in the E-Brochure. The applicants must necessarily, in their own interest, go through this Brochure before attempting to fill up the online Application Form.

The applicants are advised to fill the online Application Form on their own or through a responsible person. The applicants can also contact the **Help Desk** of I.T. Section of BOPEE on 0191-2470102, 0194-2437647, 9697383737, 9596243215, 9419434133 for any assistance/guidance in this regard on all working days.

Submission of Online Application Forms

The candidates (open merit as well as reserved categories) need not to submit any Confirmation Page in the BOPEE office but they will have to **upload their certificates online** during submission of Application Form. However, the in-service candidates working in Govt./Semi Govt. departments (Permanent or Probation) have to submit Confirmation Page of their online Application Form along with 'No Objection Certificate' from their respective departments in the office of the J&K Board of Professional Entrance Examinations,(BOPEE) Srinagar/Jammu on all working days from 11:00 A.M. to 5:00 P.M. from **21st December, 2015 to 15th January, 2016**.

The Candidates (**only in-service**), who fail to deposit their Confirmation Page of Application Form complete in all respects (including NOC) by **15th January, 2016** up to 5:00 P.M., shall have to pay a late fee of Rs. 1000/- (Rupees one thousand only) through a non-refundable bank draft drawn in favour of the FA/CAO, BOPEE payable at Jammu/Srinagar or transfer the said amount in the BOPEE's Bank Accounts through POS machines available at BOPEE offices by or before **1st February, 2016** upto 05:00 P.M. where-after no Confirmation Page will be accepted. The confirmation page of the Application Form of in-services candidates will not be accepted if it reaches BOPEE office/Srinagar/Jammu after the stipulated time, even if it is posted within the prescribed last date with late fee for submission of the Application Form.

The Application Forms (Confirmation Page) of in-service doctors must be routed through concerned Director, Health Services Jammu / Srinagar, otherwise their Application Forms shall not be entertained.

The candidates can change/modify their online Application Form at any time before its submission. They are advised, in their own interest, not to share their login details with anybody, lest he/she may change important details in the Application Form. They can check the status of their Application Form after **30th January, 2016** on the official website of the BOPEE. If any form is not confirmed for want of required information, the candidate concerned must report in the BOPEE office by or before **3rd February, 2016** failing which his/her Application Form shall be rejected.

Eligibility conditions for appearing in the Entrance Test:

A candidate must:

- (a) be a permanent resident of J&K State;
- (b) possess MBBS/BDS Degree or its equivalent Degree recognized by the University of Kashmir/Jammu and the Medical Council of India/Dental Council of India;
- (c) be registered with the MCI/DCI/State Medical Council/ State Dental Council;
- (d) have completed satisfactorily one year pre-registration compulsory rotatory internship in a duly recognized institution as laid down by the University of Jammu/Kashmir for registration as a Medical/Dental graduate.

(Note:-The Candidates, who are likely to complete their compulsory rotatory internship and registration from MCI/DCI/State Medical/Dental Council by or before his/her turn of counselling, can also appear in the Entrance Test. However, such candidates cannot be allowed to participate in the counselling, if they fail to produce prescribed certificate to this effect);

- (e) have a valid Category Certificate (For candidates claiming benefit of any reserved category) signed by the prescribed Competent Authority as required under rules. The candidate(s), who mentions any reserved category in the online Application Form but either does not possess a valid category certificate or possesses it but fails to submit it along with the Application Form, shall be considered in open merit, if he/she is found otherwise eligible.

Other conditions:

- (a) A candidate claiming marks under SRO 401 dated 19-12-2009(Difficult Area Service) should upload a certificate along with the Application Form which should be signed by the Director, Health Services, Jammu/ Srinagar to the effect that he/she has served in the difficult area(s) as enlisted in SRO 201 of 2006 dated 15-6-2006.
- (b) The candidates of reserved categories shall be treated as one unit in terms of Rule 15 of the Reservation Rules, 2005 for the purposes of allotment of Streams/Institutions.
- (c) The candidates must secure minimum qualifying marks in the Entrance Test for selection in the Post Graduate Degree and Diploma Courses in accordance with the J&K Reservation Rules and the MCI/DCI Regulations, as amended from time to time.
- (f) The Non permanent resident Doctors having MBBS degree from any University of J&K State and whose parents are presently serving in J&K State are eligible to appear in the Entrance Test in terms of SRO 158, dated 12 July, 1995 as open merit candidates.
- (g) The sports category candidates must indicate category in their Application Form and must submit category certificate(s) to the Sports Council for awarding points which shall then be officially forwarded to the BOPEE. The Sports category candidates, whose sports points are

not either received within the prescribed date or who fail to secure any point, shall be considered as Open Merit candidates, if found otherwise eligible.

- (h) The candidates, who have already done Post-Graduation or Diploma and want to undergo Post-Graduation in any other specialization, must be eligible in terms of SRO 08 of 2005. However, the candidates presently pursuing any PG/Diploma Course in any specialty at the Govt. expenses are not eligible to apply for appearing in the Entrance Test for undergoing Post Graduation in any other specialty, if they are not likely to complete their final/end term examination by or before the last date prescribed for submission of Entrance Test Application Forms.

NOTE:

1. ***The candidates are hereby sternly warned against resorting to any unfair / fraudulent means or act of impersonation. In case a candidate is found taking recourse to such acts, criminal proceedings shall be launched against him/her, besides debarring him/her permanently from appearing in the entrance examinations. Moreover, disciplinary action shall be recommended against the candidates who are in Government service, if they indulge in such practice.***
2. ***If at any stage, it is found that a candidate has given any false or incorrect information in respect of any eligibility condition, or has uploaded any unwanted Photograph/image, his/her candidature will be cancelled without any further notice and will be liable for criminal prosecution under relevant laws. The Board also reserves the right to claim compensation from such applicant (s) for their illegal / nefarious actions/activities.***
3. ***NO "UNDER PROCESS" CERTIFICATE WILL BE ENTERTAINED IN ANY CASE***
4. ***Incomplete Application Forms shall be summarily rejected.***
5. ***No correspondence shall be accepted in case any Application Form is not entertained or is rejected for a valid reason.***
6. ***Details regarding tentative number of seats in Medical Colleges/Dental College, eligibility criteria, Entrance Test, documents to be submitted, photographs etc. have been provided in the Electronic Information Brochure which is available on the official website. The seats indicated in the Information Brochure are yet tentative and subject to the final approval from MCI/DCI/State Government, as the case may be.***
7. ***Mere uploading of any reserved category certificate will not confer any benefit to the candidates if it is later on found invalid under rules and/ or guidelines issued in the Electronic Brochure***

Issuance of Admit Cards and Date of Entrance Test

Information with regard to availability of online Admit Cards, Venue and Time of the Entrance Test will be issued separately in due course of time.

The Entrance Test will be held on **28th February 2016, (Sunday).**
