## NOTE:

- 1. The exact date of commencement of the examinations and detailed time-table will be notified later.
- 2. The Examination application forms of ALL students (all batches) are to be submitted online through college login. Also, hardcopy of the same may be downloaded and submitted to the examination branch duly signed by the Student and the principal concerned along with photocopy Memorandum of Marks of earlier examination.
- 3. The Examination fee once paid by the candidate/College will not be refunded or adjusted.
- 4. The Principal **Sri Venkateshwara College of Fine Arts, Hi-Tech City, Madhapur** Hyderaba is requested to:
  - (a) Inform their students that the examination fee & application forms will not be accepted after the due date.
  - (b) Instruct the students to enclose the Xerox copies of the memorandum of marks of qualifying examination to verify the eligibility.
- © Forward only the examination application forms of the candidates who have **put in required percentage of attendance.**

(d) The payment of Examination fee is accepted through Core Banking System from the colleges under Osmania University Jurisdiction and the same was communicated Vide Lr. 171207/COE/2007, dated 17-12-2007.

1. The Colleges those maintaining their account with the branches of State Bank of Hyderabad, can remit the fees through the same branch for credit of Registrar Osmania University Exam Fee Fund A/c No. 52198262033 maintained with Osmania University Branch of State Bank of Hyderabad.

2. In case the College is maintaining its account with any Bank other than State Bank of Hyderabad, are required to put money in any Branch of State Bank of Hyderabad for credit into Registrar Osmania University Exam Fee Fund A/c No. 52198262033.

3. Further, after remitting the examination Fee into the Registrar Exam Fee Fund Account through Core Banking System the colleges can obtain a receipt from the Bank and submit the same to the Examination Branch along with Examinations forms.

4. Hence, collect the examination fee as per the enclosed schedule from the candidates at the college and remit to the account and obtain the receipts from the bank.

- (e) i. Submit the application forms Online, of the candidates who have applied without late fee on or before <u>03-03-2014</u> and remit the fee to Osmania University a/c on <u>03-03-2014</u>.
  - ii. Submit the application forms Online, of the candidates who have applied with a late fee of Rs. 100/- on or before <u>10-03-2014</u> and remit the fee to Osmania University a/c on <u>10-03-2014</u>.
- 5. Submit all the **Application forms** along with the:
  - I. **Consolidated fee receipts** obtained from the SBH Bank. (In no case individual receipts submitted by the students will be accepted)
