- 3. A separate notification will be issued soon after the declaration of the results of Supplementary Examinations (Oct/Nov) 2016, to enable the candidates having backlogs to register for the UG Annual Examinations to be held in March/April 2017.

- 5.  - b) Inform all the concerned candidates that the payment of examination fee & submission of application forms will not be entertained after the due date <u>under any circumstances</u>. The Examination fee once paid by the candidate will not be refunded or adjusted.
 - c) Note that the H.T No allotted to a candidate at the time of admission shall not be changed or allotted to another candidate, even if the first candidate has cancelled his/her admission.
