THE REQUISITION FORM FROM THE CANDIDATES FOR REVALUATION OF THEIR SCRIPTS SHALL BE ADDRESSED TO DEPUTY REGISTRAR (EXAMS), SCHOOL OF DISTANCE EDUCATION, ANDHRA UNIVERSITY, VISAKHAPATNAM AND REACH HIM WITHIN A PERIOD OF 30 (THRITY) DAYS FROM THE DATE OF DESPATCH OF MARKS AFTER PUBLICATION OF THE RESULTS AT THE OFFICE OF THE SCHOOL OF DISTANCE EDUCATION.
5. THE CANDIDATES DESIRING REVALUATION OF THEIR VALUED ANSWER SCRIPTS ARE
