THE SPECIMEN HAND-WRITING OF THE CANDIDATE SEPARATELY FOR EACH ANSWER SCRIPT TO BE RE-VALUED SHALL BE ENCLOSED TO RE-VALUATION APPLICATION. 5. THE RESULTS AND MARKS STATEMENTS/CERTIFICATES ISSUED WIL BE CANCELLED AT ANY TIME IF THE INFORMATION FURNISHED BY THE CANDIDATE IN THE EXAMINATION APPLICATION IS FOUND INCORRECT AND IF HE/SHE HAS BEEN DEBARRED BY THE UNIVERSITY EARLIER AND UNDER THE PERIOD OF RUSTICATION i.e., DEBARRED PERIOD.
