E., RS. 300/- (RUPEES THREE HUNDRED ONLY) IN RESPECT OF EACH SCRIPT OF B.COM. II YEAR AND HAND-OVER THEM TO THE CONCERNED COLLEGE PRINCIPAL WHERE THEY HAVE STUDIED ON OR BEFORE 02-11-2009. THE SPECIMEN HAND-WRITING OF THE CANDIDATE SEPARATELY FOR EACH ANSWER SCRIPT TO BE RE-VALUED SHALL BE ENCLOSED TO RE-VALUATION APPLICATION.
