## UNDER-GRADUATE PROGRAMME (Five Year Integrated B.A.L.L.B. (Hons.) Course)

Educational Qualification: Passed 10+2 or equivalent examination with a minimum of (i) Forty Five percent (45%) marks in case of candidates belonging to General/OBC/Specially abled persons categories and (ii) Forty percent (40%) marks in case of candidates belonging to SC/ST category. A candidate appearing in the qualifying examination in March/April 2016 is also eligible to apply.

Age Limit: No age limit is prescribed for CLAT-2016

### POST-GRADUATE PROGRAMME (One Year LL.M. Course)

Educational Qualification; LL.B. or equivalent degree examination with a minimum of 55% marks in case of General/OBC/Specially abled persons categories and 50% in case of SC/ST category. A candidate appearing in the qualifying examination in April/May 2016 is also eligible to apply.
