This is the final chance for 2013 admission candidates to take the ninth semester examinations of B. A. LL. B. Programme.

Applications for examination registration can be downloaded from the university website www.kannuruniversity.ac.in.

The Head of the Department of Law shall forward the application for examination, chalan receipt, statement of fees on or before the last date prescribed, to the Controller of Examinations. The HoD shall verify and certify the affidavits submitted by the SC/ST candidates (receiving the grant directly to their bank accounts) and other eligible candidates availing fee concession (receiving the grant through the institution's bank account) who have not remitted the examination fee during registration. Fee payment can be made through SBI Collect/ Treasury Chalan. The candidates who receive the grant directly to their bank account shall remit the fee amount in the University as and when it is received from the Government Department concerned. Fee in respect of candidates availing fee concession received through the institution's bank account shall be credited to the Kannur University Fund and details of such remittance shall be informed to the Examination Branch without delay. If any candidate receiving grant through the institution's bank account has remitted the examination fee during registration, the department shall reimburse the amount to the candidate.

Penalty will be levied for delayed submission and non- submission of data (exam applications, APC and Internal Assessment Marks) as per rules.

Candidates with shortage of attendance will not be issued hall tickets, until the Head of the Departments recommends and states that the shortage is within condonable limit and the application for condonation has been forwarded to the Registrar.

Students of 2013 and 2014 admissions should re-register themselves for the programme by remitting re-registration fee of ₹4000/- as per reference cited (1) above. Those candidates who have already re-

registered should attach the re-registration memo along with the application form for examination. The results of these students will be published only after the completion of re-registration process.

The application for re-registration (in the format available on the university website), along with the chalan receipt, should be submitted to the Registrar whereas, the application forms for examinations along with the chalan receipt should be submitted to the Controller of Examinations.

BA LLB Course – Extension of the duration of the Course after the expiry of the stipulated period - Amendment to the Regulations - Approved – Orders issued

ORDER

1. As per the Regulations, Scheme and Syllabus for B.A LLB course implemented in the University w.e.f. 2009 admission , it is specified that the time limit for the completion of the Course is “Eight years” from the commencement of the course.

2. Meanwhile certain students of 2009 admission who have not completed the aforesaid Course, within the stipulated time requested for Re – registration. Since the Regulations of B.A LLB Course is silent on Re – registration, the matter was placed before the Sub Committee of the Syndicate, vide reference cited (1) .

3. As per the reference cited (2) above, the Examination Branch informed that after considering the opinion of the Chairman, BOS in Law and the U G C Regulations, request of the candidates is granted by the Sub Committee. Thus the Sub Committee recommended to extend the Maximum duration for completion of the Course, for 2 Years more, after the expiry of the stipulated period specified in the Regulations with a Re – registration fee of Rs.4000/- .

4. The above recommendations of the Sub Committee were approved by Syndicate vide paper read (4) above.

5. Therefore the Vice Chancellor, in exercise of the powers of the Academic Council, conferred under Section II (1) of Kannur University Act, 1996, accorded sanction that maximum duration for completion of the B.A LLB Course of the Department of Law of the University is extended to further Two Years more, after the expiry of the stipulated

period of 8 years. Re – registration fee for this purpose is fixed as Rs.4000/- (Rupees Four Thousand only).
