

Submission and uploading of application form:

- 1) The Principals are requested to register the student enrollment through online only (Photography and Signature of the Student to be Scand). The website address is **www.kuonline.co.in**.
- 2) Application form(s) **will not** be accepted directly from any candidate or from the Principal after the due date.
- 3) The Students of **I Sem** Regular Candidates should apply through **Online** only while Ex and Improvement candidates should apply through Online/manual only.
- 4) Collect examination fee as per the schedule from the candidates and send the same to this office along with consolidated demand drafts separately in accordance with the above schedule. The Demand Drafts should be drawn in favour of the **"Registrar, KU., Examinations Account"** Payable at State Bank of Hyderabad (Code No.262) K.U., Branch, Warangal, 506009. The DDs' amount should tally with the amount shown in Nominal Rolls.

Following is the Schedule for submission of application forms and nominal rolls

- A. Application forms along with
 - i. **3 hard copies** of online generated nominal rolls & **Paper wise Statistics**
 - ii. 'No Dues Certificate' from the Academic Branch, K.U.,
 - iii. 'No Dues Certificate' from Dean, College Development Council, K.U.
 - iv. 'No Dues Certificate' from Dean, Academic Affairs, K.U.
- B. Every application must possess a receipt of payment issued by the college towards examination fee collected from the candidate, failing which it will not be accepted.
- C. Application forms should be scrutinized and signed by the Academic Coordinator of the college in accordance with the guidelines and instructions issued and should be tied separately in chronological order. Applications of not eligible candidates are liable for rejection at any stage whenever they are detected. For this, the University will not be held responsible in any manner.
