Further, it may please be noted that **application forms will not be accepted under any circumstances** after 11- 11- 2018. For late submission of application forms, a penalty of Rs. 2,000/- per day will be charged against the colleges. The detailed Time-Table will be notified in due course.

Instructions to the Candidates:

- 1. The Candidates have to submit a xerox copy of the memo of marks of qualifying examination along with their application forms.
- 2. The Candidates should confirm their eligibility as per the norms before remittance of examination fee. Fee once remitted will not be refunded or adjusted under any circumstances.
- 3. *Late fee of Rs.1, 000/- will be imposed* for according late permission to the Candidates after the due date. No application will be entertained after the commencement of exams.
- 4. The appearance in the examinations by the candidates will be subject to eligibility and promotion norms. They will forego the results of the Exams appeared in deviation of norms.

The Principals of the colleges concerned are requested to adhere to the following:

- 1) Ascertain the eligibility of the Candidates before sending NRs Forward the applications of only eligible candidates. If any deviation found, College will be penalized @ Rs. 20,000/- per each deviation as per the norms.
- 2) The demand draft(s) shall be drawn in favour of the "Registrar, KU Examinations Account" payable at the State Bank of India, K.U. Branch (Code No.0020262), Warangal.
- 3) To submit the following along with the Nominal Rolls of the Candidates:
 - 1) Application Forms
 - 2) No Dues certificate from the Deans of College Development Council and Academic Audit for every exam and from Academic Section for the I Year or I Semester Exams of any course, KU
 - 3) Required fee in the form of D.Ds.
 - 4) 3 Sets of downloaded NRs
 - 5) Practical Examinations shall be conducted during the stipulated period.
 - 6) Internal/ Sessional Marks should be uploaded online through <u>kuonline.com</u> and submit the hard copies at the Examination Branch.

Note:- The Last date for submission of Dissertation is 20th January, 2019. If any student fails to submit the dissertation before the said date, they will no be allowed to attend the Viva-Voce. They have to attend with the next academic year batch.
