The Colleges maintaining their account with the branches of State Bank of Hyderabad (SBH) OR any other bank are required to deposit the consolidated amount in any branch of SBH for Credit into **“Registrar, Examination Fee Fund A/c No.52198262033”** and can obtain a receipt from the bank and submit the same to the Examination Branch along with Examination forms on or before **08-10-2014**.

Application Forms submitted after 08-10-2014 will have to pay a Penal fee of Rs. 1000/- per day.

NOTE:

1. As a part of the Core Banking System, all the students are hereby instructed to deposit the Examination Fee into their **respective College Accounts** only for onward Transmission to the University by the college.
2. The students are advised to enclose xerox copies of their previous examination Memo of Marks attested by the College Principal concerned with the Examination Application Forms.
3. The examination application forms of II year I semester students admitted during the academic year 2013-2014 are to be submitted **Online through College login**. Also, hard copy of the same maybe downloaded and submitted to the Examination Branch duly signed by the student and the Principal concerned.

- Any discrepancies with regards to the Candidate's data such as **Internal Marks, Practical, Viva –Voce and Project etc.**, should be brought to the notice of concerned officials of Examination Branch and obtain the acknowledgement within one month of declaration of results.
