The students are advised to enclose Xerox copies of their qualifying examination certificates attested by the College Principal concerned with the Examination Application Form and Migration Certificate, if any, with Migration Fee of Rs.125/-( if the candidate belongs to other than O.U./ SBTET).
- 2. The Principals are requested to furnish the list of candidates admitted in their Colleges during the academic year 2013-2014 duly approved by the Convener, EAMCET and also the Director, Admissions, O.U.
- 3." NO DUES CERTIFICATE " from the Director, Academic Audit Cell, O.U., may also be enclosed with the forwarding letter.
- 4. the college has to get clearance letter from the Director, Academic Audit Cell, O.U. and the Examination Application Forms of II/I Students admitted during the academic year 2013-14 are to the submitted online through college log-in. Also hard copy of the same may be down loaded and submitted to the Examination Branch duly signed by the student and Principals concerned along with photocopy of previous qualification.

- 5. The Principals/Directors are requested to collect the Processing Fee from each student of the fresh batch @ Rs.300/- and remit the consolidated amount into above mentioned account.
- 6. All the Principals are requested to verify the eligibility of the students thoroughly and forward the same to this office for the issue of Hall Ticket. If failed to verify the eligibility of the candidates, the principal is held responsible for the issue of hall ticket by this office to the non-eligible candidates.
