Xerox copies of Examination Application Forms & Photographs will not be considered.

Note:-

- 1. The candidates appearing for M.Ed II Semester Examinations are advised to enclose the xerox copies of M.Ed I Semester Memo of Marks.
- 2. The Principals are requested to verify and forward all the Online Examination application forms on or before <u>10-04-2014</u> along with Nominal Roll, fee particulars & subject-wise data in duplicate.
- 3. A penal fee of Rs.1,000/- per day shall be levied if the colleges fails to submit the application forms within the stipulated date i.e., without late fee forms on or before 10-04-2014.

- 4. As a part of the Core Banking System, all the students are hereby instructed to deposit Examination fee into their respective College Principal's account only (students are advised not to obtain the DD in favour of the Controller of Examinations, OU).
- 5. The concerned Principal's are requested to deposit (credit) the Consolidated Examination fee amount into <u>"Registrar, Osmania University Examination fee Fund A/c No:52198262033" in any branch of State Bank of Hyderabad</u> and obtain a receipt from the bank and submit the same to the Examination Branch, OU along with application forms.
- 6. All the candidates who are appearing the M.Ed II Semester Examinations should write the exams only in the English as per the University Rules.
- 7. The application forms will not be accepted unless the college submits clearance certificate from the Superintendent, Stores Section of the Examination Branch, OU with regard to the account of 32 pages booklet stationery.
- 8. THE COLLEGES ARE REQUIRED TO ENCLOSE THE CLEARANCE CERTIFICATES ISSUED BY THE STORES SECTION OF THE EXAMINATION BRANCH AS A PROOF FOR THE UNUSED EXAMINATION STATIONERY RETURNED BY THE COLLEGE PERTAINING TO THE EXAMINATIONS CONDUCTED EARLIER.
- **9.** The Principals of the Colleges are required to submit the application forms in the Office of the Controller of Examinations after obtaining the endorsement from the Director, Academic Audit Cell, OU. Applications will not be accepted without the endorsement of the Director, Academic Audit Cell.
