6. No Examination Application Forms will be accepted without fulfilling the conditions mentioned above.

"Any discrepancies with regards to the Candidate data such as Internal Marks, Practicals, Viva-voce and Projects etc, should be brought to the notice of concerned officials of Examination Branch and obtain the acknowledgement within one month of declaration of results. After one month, queries will not be entertained.
