5. Fee once paid will not be refunded or adjusted under any circumstances.

I am herewith enclosing the Notification of B.A.(L)/B.A/B.Com/B.Sc/B.B.M (UG Courses) Instant examination to be held on **28/05/2015**. You are requested to bring it to the notice of the students and the staff concerned immediately. The following guidelines may be followed.

1. 2. The Hall tickets may be issued to the eligible students by the principals concerned after verifying the applications.
3. After issuing Hall tickets to the students, you are requested to send the duplicate Hall Tickets, one copy of Nominal rolls to the allotted center and the other copy of the application form, nominal rolls to the examination Branch along with the consolidated DDs.
