Students can obtain application forms for Revaluation / Recounting from the Examination Branch, Telangana University, Nizamabad or from the office of the concerned college.

The application for Revaluation / Recounting should be submitted along with a photocopy of the memorandum of marks.

#### Fee Particulars are as below:

1.	Revaluation	:	Rs.500/- each paper
2.	Recounting	:	Rs.300/- each paper
3.	Revaluation/Recounting form	:	Rs.25/- each

The College Principals are requested to collect the Revaluation / Recounting fee from the candidates at the college as per the schedule and deposit (credit) the consolidated Revaluation /Recounting fee amount in to the Registrar, **Examination Account (A/c.No.31079102875) SBI Telangana University Branch** or in any branch of State Bank of India and obtain a receipt from the bank on <u>27-04-2016</u> and submit the same to the examination branch, Telangana University along with application forms with all above requirements on or before <u>29-04-2016</u> by 4.00 P.M. without fail. The students of campus colleges have to pay the fee through B Challan (which is available in the college office) in favour of the **Registrar, TU, Examinations Accounts** payable at State Bank of India, Telangana University Branch (Code No.13804), Nizamabad – 503 322. No action will be taken unless the application form is accompanied with a photocopy of the memorandum of marks. In no case, the fee is refundable.
