For

### BA-LL.B & B.Pharm Courses (Session 2016)

On-line Applications are invited from the eligible candidates for admission to the below mentioned courses for the academic session 2016. The candidates are advised to peruse the Prospectus-2016 available on University Website thoroughly and check eligibility/other details before submitting their application forms.

- I) BA-LL.B (5 year Integrated Course)
- II) B.Pharm (4 year Course)

#### Eligibility Criteria:

- i) **BA-LL.B:** 10+2 in any stream or an equivalent course recognized by the University with 45% marks for Open Merit and 40% for Reserved category. The maximum age for seeking admission is limited to twenty years in case of General category and twenty two years in case of Reserved category candidates as on **October 20, 2016**.
- ii) **B.Pharm:** 10+2 (Biology background) with 50% marks for Open Merit and 45% for Reserved category.

#### Admission Criteria:

The admission will be made on the basis of Entrance Test comprising of Objective Type Questions, to be conducted by the University. The outline of the syllabus is uploaded on University Website at [www.kashmiruniversity.net](http://www.kashmiruniversity.net). The date of Entrance Test shall be notified separately.

#### Submission of On-Line Application Forms:

The candidates are advised to follow the following steps for filling their On-Line Application Forms.

**Step-1:** Visit <http://www.kashmiruniversity.net> and click on Link **Admissions 2016**.

**Step-2:** Candidate need to register him/herself before submitting the Online Application Form. For Registration with the System Click on the Register as Student line. Remember the Username and Password for future reference.

**Step-3:** After successful Registration, login into the system for submitting On-line Application Form. Enter your Registration No. and Click Search.

**Step-4:** Select the desired Programmes and Campus Preferences and Upload your latest passport size Photograph and specimen signature.

**Step-5:** Preview the Form displayed on the screen. If details are correct, click on Submit. If there is any variation click on Previous button, make corrections and then Submit. Get a printout of the Form and note the Form No. for future reference.

**Step-6:** Deposit the application fee of Rs. **600/-** for one Programme (plus Rs. 10/- Bank charges) against the Bank Pay-in-Slip generated with the Application Form, in any of the branches of the J&K Bank Ltd. across the Country.

**Submission of Hard Copy of Application Form:**

The candidates after submitting their On-Line Application Forms must submit the downloaded Form (hard copy) with the following documents in the concerned Department (**Department of Law/Department of Pharmaceutical Sciences**):-

- i) Marks Certificate of the examinations passed
- ii) State Subject Certificate
- iii) Date of Birth Certificate
- iv) Reserved Category Certificate (if claiming admission under Reserved Category)
- v) NOC from the employer, in case employed in any Government or semi Govt. Department.
