Procedure for Paying Examinations fee through online

Step 1 : Go to Anna University website (<u>www.annauniv.edu</u>) then go to ACOE office website (<u>http://acoe.annauniv.edu</u>) [Google Chrome is the preferred browser but all the latest browsers will support]

Step 2: Select (Click) "Examination Fee Payment Nov / Dec 2016".

- Step 3 : Enter the Registration Number and Date of Birth in the login form and Press Login button. The respective student's particulars (Arrear / Regular) will be displayed on the webpage. If all the information are correct, then press "**Confirm**" button.
- Step 4 : On confirmation, the user will be requested to select the mode of Payment and the details on the webpage and proceed to the respective bank's website for payment (enter the login name, password and proceed).
- Step 5 : On successful completion of the transaction, the candidate can take a print out of the receipt.

- 1. The Arrear examination for the UG (Full Time) under Regulation 2002/2004 will be conducted based on the syllabus of Equivalent subjects in Regulations 2008 which is hosted in ACOE office website(<u>http://acoe.annauniv.edu</u>)
- 2. The Arrear examinations for the UG (Part Time) under Regulation 2002/2005 will be conducted based on the syllabus of Equivalent subjects in Regulations 2009 which is hosted in ACOE office website(<u>http://acoe.annauniv.edu</u>)
- 3. For Non Equivalent subjects the Examination time table will be intimated shortly.
- 4. Students under NRI / Foreign National Quota must also pay their arrear examinations fee through online, before the last date.
