Sub: JNTUA – R & D – Supernumerary seats without entrance examination for admission into Ph.D. programme for Executive in Industry/State and Central Govt. Organizations/Scientists from R & D Organizations/Public Servants as well as Foreign students and regular scholars – Reg.

Vide ref. cited above, the Hon'ble Vice-Chancellor has approved the guide lines providing supernumerary seats without entrance examination for admission into Ph.D. Programme for the Technocrats working in the Industry/State and Central Govt. Organizations/Scientists from R & D Organizations/Public Servants as well as Foreign students and regular scholars. Ph.D ADMISSIONS FOR INDUSTRIAL EXECUTIVES/FOREIGN NATIONS/PIOS/NRIS/ REGULAR SCHOLARS

The following categories of candidates are eligible for admission into Ph.D. part-time/full-time programme without entrance examination/notification under supernumerary quota subject to approval by the Academic Standing Committee (ASC).

- 1.1. Executives from Industry/State and Central Govt. Organizations/ Scientists from R&D Organizations/Public Servants:
 - i. Executives with at least 55% marks in Master's Degree and working in the Central & State Government Organizations / Joint Stock Companies with at least five years of service in a senior cadre comparable to that of Assistant Professor cadre or above are eligible for admission to the Ph.D programme (part-time) in core/interdisciplinary subject.
 - ii. Executives sponsored by the industry having turnover of at least Rs.5.00 Crore per year with a minimum of 5 years experience, working in a Grade equivalent to that of Assistant Professor cadre or above and at least 55% marks in Master's Degree are eligible for admission to the Ph.D programme (part-time) in core/interdisciplinary subject.
- iii. Scientists/Scientific Officers working in State/National/International research Institutes/Organizations in a senior cadre equivalent to that of an Assistant Professor cadre or above with a minimum of five years of experience and at least 55% marks in Master's Degree are eligible to register themselves in the Ph.D (part-time) programme.
- iv. Central Civil Service Officers (Class-1) / Group-1 officers of A.P. Government with five years of experience and at least 55% marks in Master's Degree are eligible for admission into Ph.D (parttime) programme.
- Member of Parliament (M.P.), Member of Legislative Assembly (M.L.A.) and Member of Legislative Council (M.L.C.) with at least 55% marks in Master's Degree are eligible for admission into Ph.D. (part-time) Program in the core/ interdisciplinary area.
- vi. Regular faculty working in Constituent units of JNTUA with minimum 2 years of experience in JNTUA with at least 55% marks in Master's Degree are eligible for admission into Ph.D. (part-time) Program in the core/ interdisciplinary area

The candidates admitted for Ph.D vide the categories 1.1.(i) to 1.1.(v) have to pay an annual fee of Rs.60,000 until the date of submission of PhD thesis.

1.2. Foreign Nationals/NRI's/ PIO's for Full-time Ph.D program:

Foreign Nationals can apply for Ph.D (full-time) program under the following categories:

- (i) Foreign Nationals sponsored by Indian Council for Cultural Relations Award (ICCR)/EdCIL
- (ii) Foreign nationals/NRI's/PIO's under self- finance

The candidates admitted for Ph.D vide the categories 1.2.(i) and 1.2.(ii) have to pay an annual fee of **US \$3000** until the date of submission of PhD thesis.

1.3. Regular Scholars for Full -time Ph.D program

- i. Employees who are sponsored by their employers for doing research work in any one of the constituent colleges and having at least 55% marks in Master's program can apply for full-time Ph.D program. They will not receive any financial assistance from the University and need to mandatorily submit sponsorship letter along with the application.
- ii. The candidates who receive financial assistance under various Govt./Semi Govt. schemes like CSIR, UGC, DAE, DST, DBT, NBHM, BRNS, etc. with at least 55% marks in Master's program and one year research experience in the project as well as one research publication/National Conference can apply for full-time Ph.D program.
- iii. Any candidate with atleast 55% marks in Mater's program and not in requirement of any financial support from the University can apply for full-time Ph.D program under self financed category.
- iv. Candidates possessing MS (by research)/M.Phil degrees awarded by JNTUA can apply for Ph.D program, either full-time or part-time, in relevant core/ interdisciplinary areas.
 The candidates admitted for Ph.D vide the categories 1.3.(i) to 1.3.(iii) have to pay an annual fee of Rs.40,000 until the date of submission of PhD thesis. However, the candidates admitted

under category 1.3(iv) will have to pay an annual fees of Rs.40,000 for full-time Ph.D and Rs.60,000 for part time Ph.D.

General Guide lines

- The Ph.D admissions taken up in all the above categories (1.1 to 1.3) shall be considered supernumerary and the eligible supervisors of the constituent colleges will be sanctioned with additional three students, one in each category, under over and above the existing limit (i.e. 8 for Professors, 6 for Associate Professors and 4 for Assistant Professors).
- In case there are no applicants under category 1.3, such seat may be filled with candidates under categories 1.1 and 1.2 if available.
- The categories 1.1 to 1.3 are only applicable to constituent colleges/units of JNTUA only, however, if a candidate joins under category 1.2 in any of the recognized research centers of the University, the fee paid by the candidate will be shared in the ratio of 40:60 between university and the respective affiliated college, respectively.
- Admission to Ph.D program under the above (i.e 1.1 to 1.3) categories are open throughout the year.
- The candidates admitted under these categories are governed by the existing regulations of the university applicable for full time/part time scholars.
- Director, Admission will look after the admission process of students under these categories and interested candidates may approach the Director, Admissions
