In case the seats are available, the Principals may grant late admission on payment of late fee as under:-

a)	First 7 days	04-08-2017 to 10-08-2017	Rs.260/-
b)	Another count of 7 days delay after expiry of last date as (a) above	11-08-2017 to 17-08-2017	Rs.500/-

The Vice-Chancellor may consider grant of late admission for one month only after the expiry of last date as per (b) above on payment of Rs.2400/- subject to the condition that wherever income of a candidate's parents is below Rs.4800/-, she/he be exempted from payment of Rs.2400/-. However, late fee shall be charged in such cases as prescribed at 'b' above.

Admission in the above course shall be made irrespective of the holidays or vacation.

The regular teaching work of the class shall begin within a week after the close of acmission (with late fee i.e. w.e.f 18-08-2017).

"A candidate who is placed under re-appear category in one subject only In Part-I or Part-II of the Three Year B.A./B.Sc./B.Com. (General) Course shall be eligible to seek provisional admission/permission to join the next higher class/examination at his/her own risk and responsibility on a clear understanding that he/she shall qualify the subject within the permissible statutory chances failing which his provisional admission/permission to the next higher class/examination shall stand cancelled."
