ADMISSION TO THE THREE YEAR B.A./B.SC./B.COM./B.B.A./B.C.A. (GENERAL) COURSE PART-IIIrd SESSION 2017-18

It is hereby notified for the information of all concerned that the admission to **Part-IIIrd (Annual Pattern)** of the Three Year **B.A./B.Sc./B.Com./B.B.A./B.C.A.** (General) Course for the Academic Session 2017-18 in the Govt./Private Degree Colleges affiliated to the University of Jammu shall be made as under:-

In case the seats are available, the Principals may grant late admission on payment of late fee as under:-

The Vice-Chancellor may consider grant of late admission for one month only after the expiry of last date as per (b) above on payment of Rs.2400/- subject to the condition that wherever income of a candidate's parents is below Rs.4800/-, she/he be exempted from payment of Rs.2400/-. However, late fee shall be charged in such cases as prescribed at 'b' above.

Admission in the above course shall be made irrespective of the holidays or vacation.

The regular teaching work of the class shall begin within a week after the close of admission (with late fee i.e. w.e.f 18-08-2017).

"A candidate who is placed under re-appear category in one subject only In Part-I or Part-II of the Three Year B.A./B.Sc./B.Com. (General) Course shall be eligible to seek provisional admission/permission to join the next higher class/examination at his/her own risk and responsibility on a clear understanding that he/she shall qualify the subject within the permissible statutory chances failing which his provisional admission/permission to the next higher class/examination shall stand cancelled."
