SPECIAL INSTRUCTIONS TO THE PRINCIPALS

- The college login will be closed after the last date.
- The late fee amount will be levied automatically in case the fee is not Remitted to the O.U. A/c and forms are not submitted as per the above schedule.
- Principals are requested not to forward/submit the EAF of Not Eligible Candidates. The results of Not Eligible candidates will be cancelled at any stage, if they write the examination.

Fee Structure: -

1) The Prescribed Examination fee for B.Ed. Special Education (MR / ID) of the Academic Year 2016-2017 candidates is Rs.1420/- + Rs.60/- (Memo of Marks charges) + Examination Processing Fee is Rs.300/- i.e., total fee is Rs.1780/-

Not to collect the Exam fee from Blind, Physically Disabled, Deaf & Dumb students as per O.U Order No. 1555/228/2007-08/Budget-V, dated: 25-03-2008. A Xerox Copy of Medical Certificate confirming their status as Handicapped (minimum percentage of disability must be of 40%) must be attached to the Application forms. Blind, Physically Disabled, Deaf & Dumb Students Application forms should be submitted separately along with Separate Nominal Roll.

Important Note:-

1. The Examination Application Forms (EAF) are to be submitted online through college login. Also, hardcopy of the same may be downloaded and submitted to the Examination Branch duly signed by the student and the principal concerned along with photocopy of qualifying examination. Xerox copies of Examination Application Forms & Photographs will not be considered.

- 2. As a part of the <u>CORE BANKING SYSTEM</u>, all the students are hereby instructed to deposit Examination fee into their <u>respective College Principal's account only</u> (students are advised not to obtain the DD in favour of the CONTROLLER OF EXAMINATIONS, OU).
- 3. The concerned Principal's are requested to deposit (credit)/transfer the Consolidated Examination fee amount into "Registrar, Osmania University Examination fee Fund A/c No:52198262033" in any branch of State Bank of Hyderabad through NEFT/RTGS and obtain a receipt from the bank and submit the same to the Examination Branch, OU along with application forms. No Demand Drafts are accepted at core Banking section at Exam Branch.
- 4. The Principals are requested to verify and forward all the <u>ONLINE APPLICATION FORMS</u> immediately along with the Name List (Nominal Roll) in prescribed Performa, subject-wise data & fee particulars in duplicate.
- 5. ALL THE PRINCIPALS ARE REQUESTED TO SUBMIT THE PRACTICAL MARKS LISTS ALONG WITH THE EXAMINATION APPLICATION FORMS ONLY.
- **6.** The Principal has to enclose the following documents along with application forms:
 - I. Convener list of allotted students
 - II. OU Affiliation Orders.
 - III. NCTE Permission Recognition Certificate for the Year 2016-2017
 - IV. Directorate of Admissions for Verification of Application forms.
 - V. Director, Directorate of Academic Audit Clearance Certificate and No Dues Certificate.
- 7. A Penal fee of Rs.5,000/- per day shall be levied if the college fails to submit the Examination application forms within the stipulated date i.e., with a late fee forms on or before 28-01-2017 along with the Name List, Fee Particulars & Subject wise data in duplicate.
- **8.** The candidates who are appearing **B.Ed.(Special Education)** Examinations has to enclose the **Previous Degree Certificate**. The **candidates other than OU** have to submit the **Migration certificates** in Original and **Migration fee for Rs.250/-** along with their application form.
- 9. The candidates are advised to enclose the their Original Rank Card and Hall Ticket of **Special Education Common Entrance Test 2016-2017**
- **10.** The Colleges are required to enclose the Clearance Certificates issued by the Stores Section of the Examination Branch as a proof for the unused examination stationery returned by the college pertaining to the examinations conducted earlier.
