- The College login will be closed after the last date.
- Principals are requested not to forward/submit the EAF of Not Eligible Candidates.
- The results of Not Eligible candidates will be cancelled at any stage, if they write the examination.

## NOTE FOR LATERAL ENTRY ADMISSIONS:

- 1. The students are advised to enclose Xerox copies of their qualifying examination certificates attested by the College Principal concerned with the Examination Application Form and Migration Certificate, if any, with Migration Fee of Rs.125/-( if the candidate belongs to other than O.U./ SBTET).
- 2. The Principals are requested to furnish the list of candidates admitted in their Colleges during the academic year duly approved by the Convener, EAMCET and also the Director, Admissions, O.U.
- 3." NO DUES CERTIFICATE " from the Director, Academic Audit Cell, O.U., may also be enclosed with the forwarding letter.
- 4. the college has to get clearance letter from the Director, Academic Audit Cell, O.U. and the Examination Application Forms of II/I Students admitted during the academic year 2016-17 are to the submitted online through college log-in. Also hard copy of the same may be down loaded and submitted to the Examination Branch duly signed by the student and Principals concerned along with photocopy of previous qualification.
- 5.The Principals/Directors are requested to collect the Examination expenses from each student @ Rs.300/- and remit the consolidated amount into above mentioned account.

### NOTE:-

- 1. In respect of the candidates who have completed Course requirement having appeared for IV year II semester and completed double duration of the Course but do not crossed (10) years from the date of admission, have to pay an additional amount of Rs.1000/- per subject, Semester-wise along with normal Semester Fee i.e. <u>08 & 09 Batch</u> only (UPTO 2007 AND EARLIER BATCH NEED NOT APPLY)
- 2. The students are advised to enclose Xerox copies of their qualifying examination certificate copies duly attested by the College Principal concerned.

- 3. The Principal is requested to send the Faculty list without which the examination forms will not be accepted.
- 4. The Principal is requested to verify the eligibility of the students thoroughly and forward the same to this office for the issue of Hall Ticket. If failed to verify the eligibility of the candidates, the principal is held responsible for the issue of hall ticket by this office to the non-eligible candidates.
- 5. The Principal may kindly forward all the examination application forms onlineThrough College login
- 6. The Principal may kindly forward all the examination application forms along with the prescribed examination fee on or before 18-10-2016 together with Nominal Rolls and "NO DUES CERTIFICATE "from the Director, Academic Audit Cell, O.U.
- 7. The Colleges maintaining their account with the branches of State Bank of Hyderabad (SBH) OR any other bank are required to deposit the consolidated amount in any branch of SBH for Credit into "Registrar, Examination Fee Fund A/c No.52198262033" and can obtain a receipt from the bank and submit the same to the Examination Branch along with Examination forms on or before 18-10-2016.

# Application Forms submitted after 18-10-2016 will have to pay a Penal fee of Rs. 1000/- per day.

- 8. The students who were transferred from the University Jurisdiction and other Universities their examinations forms should be submitted separately with the Approval of the competent authorities like Commissioner of Tech. Education, Govt. of T.S. and Director Academic Audit, O.U. with allotment of H.T.No.s.
- 9. As a part of the Core Banking System, all the students are hereby instructed to deposit the Examination Fee into their respective college accounts only for onward transmission to the University by the college.
- 10. Not to collect the Exam fee form Blind, Physically Disabled Deaf & Dumb students as per O.U. Order No. 1555/228/2007-08 /Budget-V, dated: 25-03-2008. A Xerox copy of medical Certificate confirming their status as Handicapped (minimum percentage of disability must be of 40%attached to the application forms. Blind, Physically Disabled, Deaf & Dumb students applications forms should be submitted separately along with separate Nominal Roll.
