2. The Principals are requested to pay the examination fee for received application forms and not to pay the fee for un-received application forms. Any excess fees for un-received application forms is not refundable. Individual demand drafts submitted by the students will not be accepted.
3. The Principals are requested to verify and forward all the Application forms immediately along with the Name List (Nominal Roll) in prescribed proforma, subject wise data & fee particulars in duplicate.
