1. Exam application forms duly signed by the student and the Principal concerned along with photocopy of qualifying examination should be submitted to the examination branch before the last date. I Semester Regular students should enclose migration certificate, if any, with migration fee of Rs.125/- If the candidate passed qualifying examination (UG) other than Palamuru University. The delay in submission after the last date will attracts penalty (Rs.1000/-) Xerox copies of Examination application forms & photographs will not be considered.

- 2. The Principal is requested to pay the examination fee for received application forms and not to pay the fee for un-received application forms. Any excess fee for un-received application forms are not refundable.
- 3. The Principals are requested to submit <u>COMPULSORY</u> the following documents, otherwise their forms will not be accepted.
 - 1) The detailed <u>fee statement</u> signed by the college Principal.
 - 2) Proforma of **<u>Paper wise strength</u>** particulars signed by the Principal.
 - 3) Annexure-I & Name List (Nominal Roll) in prescribed Proforma.
 - 4) The list of admitted I-Semester candidates for the year **2017-2018** signed by the Director, P.G. Admission, P.U.
 - 5) No Dues Certificate and Affiliation extension order for the year **2017-2018** with sanctioned strength issued by the Academic Branch, P.U.

6) The Clearance certificate from the Director, Directorate of Academic Audit, P.U. certificate

- 4. Not to collect the Exam fee from Blind, Physically Disabled, Deaf & Dumb students. A Xerox Copy of Medical Certificate confirming their status as Handicapped (minimum percentage of disability must be of 40%) must be attached to the Application forms. Blind, Physically Disabled, Deaf & Dumb Students Application forms should be submitted separately along with Separate Nominal Roll.
- 5. As a part of the CORE BANKING SYSTEM, all the students are hereby instructed to deposit Examination fee into their respective College Principal's Accounts only (students are advised not to obtain the DD in favour of the "Controller of Examinations", PU)
