Students can obtain application forms for Revaluation / Recounting from the Examination Branch, Telangana University or from the office of the concerned college.

The application for revaluation / recounting should be submitted along with a photocopy of the memorandum of marks.

### Fee Particulars are as below:

1. Revaluation	: Rs.500/- each paper
2. Recounting	: Rs.300/- each paper
3. Revaluation/Recounting form	: Rs.25/- each

The College Principals are requested to collect the Revaluation / Recounting fee from the candidates at the college as per the schedule and deposit (credit) the consolidated Revaluation /Recounting fee amount in to the Registrar, **Examination Account (A/c.No.31079102875) SBI Telangana University Branch** or in any branch of State Bank of India and obtain a receipt from the bank on **22.09.2017** and submit the same to the examination branch, Telangana University along with application forms with all above requirements on or before **23.09.2017** by 4.00 P.M. without fail. The students of campus colleges have to pay the fee thropugh "**B challan**" (which is avialable in the college office) in favour of the Registrar, TU, Examinations Accounts payable State bank of India, Telangana University Branch (Code No. 13804), Nizamabad. No action will be taken unless the application form is accompanied with a photocopy of the memorandum of marks. In no case, the fee is refundable.
