Separate abstract statement required about the payment of Examination Fee.

Not to collect the Exam fee from Blind, Physically Disabled, Deaf & Dumb students. A Xerox copy of Medical certificate confirming their status as Handicapped (minimum percentage of disability must be of 40%) must be attached to the Application forms. Blind, Physically Disabled, Deaf & Dumb students Applications forms should be submitted separately along with Separate Nominal Roll.

as a part of the CORE BANKING SYSTEM, all the students are hereby instructed to deposit Examination fee into their respective college Principal's Accounts only (students are advised not to obtain the DD in favour of the "Controller of Examinations", TU)

The concerned Principal's are requested to deposit (credit) the Consolidated Examination fee amount into "Registrar, Examination Accounts, Telangana

University, State Bank of India, Telangana University Branch A/c No. 31079102875" in any Branch of State Bank of India and obtain a receipt from the bank and submit the same to the Examination Branch, TU along with application forms.

The Principals are requested to submit the examination application forms to the Controller of Examinations, TU by Date: <u>20-07-2018</u>. If the Examination application forms received after due date is over, the Colleges has to pay Rs.1000/- per day as penalty for late submission of forms.

The Principals are requested to submit Internal Assessments marks Online before issuing Hall Tickets, failing which the Examination Branch is not responsible for non-entering of Internal Marks.

The College is required to enclose the clearance certificate issued by the stores section of the Examination Branch as a proof for the unused examination stationery returned by the college pertaining to the examinations conducted earlier.
